

## LC Waikiki Internet Confidentiality Agreement

1. The way of processing and using the information obtained about you and the services that you request during your visit to our website and benefitting from our services provided through this website is subject to the conditions determined under this "Internet Confidentiality Agreement".

By visiting this website and requesting to benefit from the services provided through this website, you become a party to this Contract and accept the terms and conditions mentioned.

This Contract shall have a binding force on the parties as long as it is in effect. You should evaluate this contract which you are a party of and should obtain information on its terms and conditions.

Sharing your personal data is on a voluntary basis. If you do not provide the personal data we need, it will not be possible for us to provide you with the product you require or the service you need.

## 2. Different sorts of information and the way in which we collect it

LC Waikiki only collects information you provide. This is basic information, including your name, surname, address, e-mail, Facebook and Google user names. Your personal information is gathered in order to provide feedback to you quickly when you become a member of any of our sites or you connect to our applications and to give you information about new products and campaigns.

## 3- Sharing the Personal Information

Your personal information may be shared with LC Waikiki and group companies in accordance with the confidentiality agreement in order to provide you with the product you require or the service you need. The term LC Waikiki group company includes LC Waikiki affiliates, subsidiaries, entities and third parties cooperated. These third parties are the companies that we have been cooperating with to provide you a better service; companies preparing promotions, proposals and events, suppliers assisting us in order to meet your requirements accurately and remove the technical problems, and agencies we have been consulting with to support and to improve our marketing and advertising works. In order to perform the aforementioned activities, your information shall be shared, but only as far as LC Waikiki permits. The organizations that will use the aforesaid information shall be able to access your information only for the specified activity.

As long as you authorize us, we send you e-mails for new products of LC Waikiki or the

organizations which we are working with, purchase offers, discount vouchers, special news which we believe that you might be interested in, the developments that we are glad to share with you and other promotions.

In order to perform all the activities mentioned, your approval must be obtained. You always have the right of withdrawal for the approval you have given with this contract. You can withdraw your approval with your e-mail sent to our relevant e-mail address mentioning that you have withdrawn your approval.

If you change your mind regarding your approval for your personal data to be processed and used by our company, you can cancel your membership.

LC Waikiki reserves the right to use and disclose your personal data in case of any legal obligation and in cases where it is necessary to take a legal action to protect integrity of [www.lcwaikiki.com.tr](http://www.lcwaikiki.com.tr) , to meet your requests accurately and to protect the public safety. However your information shall not be share with any third parties other than the cases stipulated in this agreement.

#### 4- Accuracy of Your Personal Information

Hereby you have undertaken that the information that you have provided as a user is accurate and valid, and in case of any amendments to the same you will notify us accordingly.

In the case that any damage or loss of rights arise from provision of invalid and inaccurate information, you shall be responsible as a user. In such cases, it will not be possible for you to lodge any claim against our company.

#### 5- Access

You have the right to control and amend all the information provided to LCW. If you want to change the information stored in our database or your contact details, you can contact us through the addresses given at the bottom of the page.

If you want your personal information to be deleted or you want to stop the use of your information, you can contact us to notify your request and carry out the cancellation process without facing any problems. In order to complete this procedure, it will be sufficient to fill in the request form.

Similarly, to stop the use of the information we have gathered from your children under your supervision or to have these information deleted, filling in the request form will speed up the cancellation process.

If you wish, you can have information about our data protection policy and procedures.

#### 6- Cookies

We use cookies to improve your use whilst surfing our website. Many browsers are automatically set up to save cookies, however they can be changed manually. By accepting to become a party to this Agreement, you also accept that you have approved our cookies. If you do not want cookies to be used, changing the settings will be sufficient. However, since the cookies plays an auxiliary role on the website; removed cookies may cause the website to run improperly therefore may prevent you from getting a fast and high quality service.

#### 7- Other Web Sites

On our website, there might be links directing to the pages not managed by LC Waikiki. When you visit any of these websites, you should take into consideration the confidentiality policy of the website which you have been directed to. LC Waikiki shall not be liable for the standards and company principles of other websites.

#### 8- Use of Social Extensions

On our website or single pages, social extensions of Facebook.com owned by Facebook.Inc are used. When you want to open a page including a social extension, your browser connects directly to Facebook servers and sends Facebook a notification indicating that you have logged in our website. If you have logged in your Facebook account, Facebook matches the notified information with your account. When you use “like” and “comment” functions of the extension, relevant data is transmitted to Facebook over your browser. Please take a look at the Facebook’s Confidentiality settings to get information about use and processing of the acquired information by Facebook.

If you do not want Facebook to gather your information from our website; please log out of your Facebook account before visiting our website.

#### 9- Rights of the Persons Whose Personal Data are processed

The persons whose personal data is processed shall have the right to learn whether his/her personal data has been processed or not; if the data has been processed, the information regarding this process; the purpose of processing and whether this data is used in accordance with its purpose or not; the third parties inside and outside Turkey gathering the processed data, and also shall have the right to request incomplete and inaccurate data to be corrected

or deleted; the relevant persons shall have the right to raise an objection if an outcome against these persons is obtained as a result of the analysis carried out by automatic systems and the right to request compensation if any loss is incurred as a result of that the data in question has been processed contrary to the applicable legislation.

#### Amendment of the Confidentiality Policy

We, as LC Waikiki, may amend our confidentiality policy from time to time whenever deemed necessary. LC Waikiki reserves its right to update the confidentiality policy and recommends its users to visit this page each time they visit this site or mobile application. In case of any amendment, we remark these amendments on this page to keep you informed in the best possible way. The amendments do not include the past as we suppose that you periodically visit and check this page. By visiting this site, you are considered to have accepted all the regulations and amendments to the "Internet Confidentiality Agreement".
